

GARDEN STATE PAINT CLUB  
December 7, 2009

The meeting was called to order at 8:15 PM, by the President, Marjorie Moser, at the home of Dorothy and Milton Quirk. In attendance were: Cyndy Hetzell, Ken Ware, Sigrid Ware, Judy Moyer, Dale Brelsford, Patti Cerio, Ashley Nolasco, Mary Kensler, Margie Moser, Debbie Kinney, T.K. Meade, Dorothy Quirk.

TREASURER'S REPORT: Mary Kensler reported a balance on hand of \$18,082.00. Motion was made (K. Ware/Cerio) and passed to pay the following bills:

- Judy Moyer: \$350.00 - website work for a year
- \$ 35.00 - balloons for the Banquet
  
- NJ Horse Council dues of \$100.00 need to be paid for 2010.

CHICK'S PAINT SHOW: Judy Moyer reported that she has not received any response from APHA in reference to our concern about holding another Paint show, in the same facility/location, so close to our April show date.

JERSEY BRED YEAR END MONIES: Marjorie announced that the Jersey Bred money will be paid out to the horses that have the highest points in each division - providing the horses have shown in the appropriate number of NJ Paint shows and the owners' memberships are up to date.

GSPHC AWARDS BANQUET/LUNCHEON: There are 103 reservations to date. Marjorie reminded the members present to: bring canned and boxed food items for the food drive, for the Directors to donate a bottle for the "Basket of Cheer" raffle, bring donations for the Silent Auction table, and baked goods to raffle for the 2010 Versatility Class. Motion was made (Kensler/Moyer) and passed that GSPHC donate two horse show stalls and two horse show classes to be raffled off at the luncheon.

WEBSITE: Judy reminded everyone that any forms that are posted on the website need to be updated for 2010.

EAB EQUESTRIAN OF THE YEAR COMPETITION: Gabby Buono will represent the GSPHC at this function.

**SHOW COMMITTEE:** It was suggested that the Club consider allowing any horse showing in Open Halter to enter the Yearling Longe Line class for half price or vice versa. This will be brought to a vote at the January meeting.

**ANNOUNCER:** Marjorie announced that Toby O'Bryan will be the announcer for our September show.

**EQUINE ADVISORY BOARD:** The Club will purchase six tickets to the awards dinner: two to go with each NJ Bred Superior horse and two for our representative at the Equestrian of the Year competition. Marjorie will check and see if Barbara Mantini wishes to continue as the GSPHC representative to the Equine Advisory Board. Marjorie will continue as the alternate delegate.

**JERSEY BRED:** GSPHC will hold their 2010 Jersey Bred classes at a GSPHC club show. There will be no "Day Money" paid out but we will get additional money added to our Jersey Bred Year End money. It is the Club's responsibility to make sure the Jersey Bred horses are eligible for the Year End money.

**YOUTH CLUB REPORT:** Cyndy Hetzell reported the following:

- The Youth Club held a Halloween party for the members.
- They also participated in the Bridgeton Christmas parade.
- Club members are still selling APHA tractor raffle tickets. They will have them for sale at the Year End Banquet/Luncheon.
- They will be holding their one day APHA Youth/Amateur show again in 2010. No date or location has been chosen.
- They will also be holding a clinic in 2010. No date has been set.

**APHA GOLD STAR CLUB/CLUB OF DISTINCTION:** Sigrid reminded the members that, if they have any material for her to submit with the application, to get it to her as soon as possible.

**NSBA CLASSES:** Patti Cerio reported that we can include NSBA classes in our show in the following two ways:

- Point the class at \$75/judge. The NSBA class would be run with the Paint class.

- Hold three Stallion Incentive classes. NSBA will add \$1,000 to each of the classes. The judge must be a NSBA judge and the class would have to be open to all breeds. NSBA chooses the shows that may hold Stallion Incentive classes. The application fee for this is \$100.00. Patti will check and see how long it takes to hear if we are accepted after we turn in our application.
- We will make a decision on the NSBA classes at our January meeting.

GREEN HORSE/GREEN RIDER: Judy Moyer reported that we collected \$420 from the Green Horse and Green Rider classes this year. Motion was made (Moyer/Nolasco) and passed that we donate \$500 this year to one of our Club members - The Bishops. Jack has had a year of medical problems and Julie was recently released from the hospital following surgery for lung cancer.

2010 YEAR END RULES AND POINT SYSTEM: Judy Moyer suggested that we need to clarify the following:

- Open Division - does not include halter or color classes.
- Membership applications must be paid with a separate check.
- The Al Ambrose Year End Photo Award (when it is awarded to the High Point Youth/Rider combination) does not include any Novice Youth, Walk Trot, or Lead Line classes.

ELECTION OF OFFICERS: The results of the election are as follows:

- President: Marjorie Moser
- Vice President: Jane Munn
- Secretary: Dorothy Quirk
- Treasurer: Mary Kensler
- Board of Directors: Patti Cerio (2 years), Debbie Kinney (1 year).  
Finishing their term on the Board are: Barbara Mantini (2 years) and Ken Ware (1 year).

APHA RULE CHANGE (Re: Chick's Paint Show): The Club would like to recommend that private show sponsors not be permitted to sponsor a show within a month of a Regional Club Paint show held at the same location.

**EZ SHOW PROGRAM:** Judy Moyer noted that the *GSPHC* EZ Show program was originally installed on the laptop that Judy donated to *GSPHC*. Due to a computer "glitch" some time ago when some problems were being worked out with the EZ Show owner, the program inadvertently got installed on Barbara Mantini's laptop. She recommends that Chick's Paint Show, if requested, not be permitted to use the *GSPHC* EZ Show program. Also, in 2010 it would be advantageous to enter the billing for the shows into the EZ Show program.

The meeting was adjourned at 10:10 PM with the next regularly scheduled meeting set for January 4, 2010, at 7:30 PM in the Woodstown Diner.
