TREASURER'S REPORT: John Moser reported a balance on hand of \$11,548.00. He noted that the \$100.00 deposit for the 2009 End of Year Awards Brunch at Scotland Run has been paid. The fundraisers held during the Awards Brunch this past December netted the Club as follows:

- \$469.00 - Silent Auction
- \$220.00 - Basket of Cheer raffle
- \$150.00 - Futurity baked goods raffle

Sigrid Ware presented a bill in the amount of \$30.00 for the purchase of post cards needed to send out membership cards.

NJ AG CONVENTION: A request was received requesting a donation of \$100.00 toward the expenses of the 2009 NJ Agriculture Convention. Motion was made (K. Ware/Harrell) and passed that GSPHC not donate toward this cause.

APHA: A letter was received from APHA noting their very timely receipt of the results from our September show.

2009 NJ HORSE EXPO: This event is sponsored by Rutgers and will be held on March 28-29.

JUDGE'S LETTER: A letter was received from Duke Neff, one of the judges at our September show, congratulating GSPHC on the quality of our show.

MEMBERSHIP REPORT: Sigrid Ware reported that, for voting purposes, everyone in attendance at our meeting tonight has a 2009 membership.

EQUINE ADVISORY BOARD REPORT: Barbara Mantini reported that, in 2008, the NJ All Breed show prize money was halved. The money designated for the classes that were cancelled due to lack of entries was not redistributed into the

classes which filled. In 2009, in order to receive NJ Bred show "Day Money", horses must be shown at the NJ Bred Show held at the NJ Horse Park.

YOUTH CLUB REPORT: Cyndy Hetzell reported that all the Youth Club information is posted on the GSPHC website.

YOUTH CLUB CLINIC: This is scheduled for April 4 or 5.

2009 YEAR END AWARDS BRUNCH: Jane Munn reported that Scotland Run is reserved for the 2009 Year End Awards Brunch and the meal price is set at \$27.00.

WEBSITE: Judy Moyer requested that any new forms for 2009 be sent to her as soon as possible so that she can keep the website updated.

GSPHC SHOW HIGH POINTS: Passed by a 7/2 vote at the December 2008 GSPHC meeting, horses must show in their respective halter class in order to compete for the GSPHC week-end high point awards. Motion was made (Kensler/Nolasco) and passed that the GSPHC show high points be designated simply as "GSPHC Week-End High Points".

APHA GOLD STAR CLUBS: Sigrid Ware reminded the members that she is requesting any information that could be included with the Club's Gold Star packet be sent to her as soon as possible.

GSPHC FOOD BASKET DONATIONS: Sigrid reported that this year she received a large enough quantity of donations to give two food baskets in GSPHC's name.

GSPHC FUTURITY: Debbie Kinney reported that this year Jane Munn will be handling the Futurity paperwork. She is beginning her solicitation for Futurity sponsors. The current Futurity rules will be reviewed before they are presented at the next GSPHC club meeting. It was noted that all Futurity entries in 2009 will need an APHA registration number in order to show.

GSPHC SHOW HIGH POINT TABULATION: Ashley Nolasco volunteered to keep the show points this year.
