

## GARDEN STATE PAINT HORSE CLUB

November 2, 2009

The meeting was called to order at 7:45 PM by the President, Marjorie Moser, at the Woodstown Diner. In attendance were: Judy Moyer, Debbie Kinney, Melissa Hetzell, Patti Cerio, Jane Munn, Ashley Nolasco, Margie Moser, Mary Kensler, Sigrid Ware, Ken Ware, Dorothy Quirk.

MINUTES: The minutes of the October meeting were read and a motion was made (K. Ware, Munn) and passed that they be accepted with the following correction: the September show profit was corrected to \$5,485.00.

TREASURER'S REPORT: Mary Kensler reported a balance on hand of \$21,041. Motion was made (K, Ware/Cerio) and passed that Sigrid Ware be reimbursed \$41.20 to cover the cost of mailing the election ballots. Jane Munn also presented a bill for \$586 to purchase the glasses/tumblers that will be awarded at the End of Year Banquet(s). This amount will be included in the previously passed Awards budget.

CORRESPONDENCE: A letter and certificate was received from APHA noting that GSPHC was a participant in the Gold Star program last year.

GSPHC YOUTH CLUB: Melissa Hetzell announced that the Youth Club is planning to have a Float in the Christmas Parade. Judy Moyer asked that someone either update or send her the information so that she can update the Youth Page on our website.

SHOW COMMITTEE REPORT: Ashley Nolasco reported the following information from the Show Committee meeting held last week:

- Frank Chick's "April Mid-Atlantic Painted Dream" Paint Show - This two day "two judge/two judge" show is scheduled to be held at the Dream Park two weeks prior to the GSPHC show next April. Judy Moyer read the draft of a letter which she has been asked to develop and send to APHA. The letter is requesting that the 2009 APHA rule (that is not scheduled to go into effect until 2010) stating that week-end "two judge/two judge" shows will be permitted be denied the Chick's show since he requested a "two judge/two judge" show prior to the rule officially taking effect.

GSPHC will also fill out an APHA rules request stating that "consideration be given to not allow an individual sponsor to hold a New Individually Sponsored APHA show within one month prior to a scheduled APHA Regional Club show at the same facility."

- The 2010 April show program has been formulated.
- The 13 Jersey Bred classes, hopefully to be held at our GSPHC show this year, have been picked.
- Cross over fee: there will be no change in this fee for 2010.
- Color Class: In the APHA rule book - this is considered neither a halter nor a performance class. For GSPHC, this class will count toward the show week-end high point award but not for any GSPHC Year End awards.
- Versatility Class: The Committee would like to see \$1,000 added to this class. Jane Munn announced that the Committee is looking for sponsorships. Any fundraising monies will be deposited into the GSPHC checking account until the payouts are made.
- NSBA Classes: There will probably be three NSBA classes included in the September show. It was suggested that adding money to these classes would be a good idea.

FUTURITIES: Debbie Kinney reported that she has transferred the \$100 left in the Futurity account to Mary Kensler, to be added into the GSPHC checking account.

EARLY SHOW ARRIVALS: The following prices were decided upon:

- Thursday - \$65/stall and \$50/hook up
- Week-end - \$65/stall and \$50/hook up

These are two separate fees - one for Thursday and another for the week-end.

BOARD OF DIRECTORS: Members will vote for three directors. The person with the least number of votes will be the Director to complete the open one-year term.
