JERSEY BRED CLASSES: Margie reported that Barbara Mantini has sent copies to the State of the judges' cards for the classes that included Jersey Bred horses. Julie Bishop will check with the State and see if they need any additional information.

TREASURER'S REPORT:

- Mary Kensler reported a balance on hand of \$34,452.00. She added that, after all of the outstanding bills are paid, the balance should be approximately \$31,000.00.
- The September show realized a profit of \$4,881.03. There are still several outstanding entry fee bills to be paid. Another Reserve High Point chair has to be purchased for the tie in the Versatility Class.
- There was \$1,020.00 of beef raffle tickets sold. Both the GSPHC Youth Club and GSPHC will receive \$275.00 from the profit.
- There is one more year on our contract with the Dream Park.

GSPHC YOUTH CLUB REPORT: Cyndy Hetzell reported:

- Three of the youth members and their chaperones traveled to Nashville and attended the APHA Youth Convention.
- The Youth Club will again be holding a clinic in March.
- The Youth Club is selling the APHA Gator raffle tickets. For each \$50.00 ticket sold, the Youth Club will receive \$25.00.
- The Youth will be collecting new pillows as donations to the Battered Women's Shelter. These pillows can be delivered to the Awards Banquet.
- They will again hold a Trainers' Lead Line class at the 2011 September show.
- The Youth members will be participating in the Bridgeton Christmas parade.
