**CHICK'S PAINT SHOW:** Marjorie reported that APHA has not yet replied to our letter referencing the Chick's Paint Show being held only two weeks prior to our April Show at the Dream Park in April.

**TREASURER'S REPORT:** Mary Kensler reported a balance on hand of \$15,151.00. The Year End awards were \$5,320.00. Jane Munn reported that she has one more outstanding Banquet bill for postage.

**BACK NUMBERS:** Barbara will check and see how many unused back numbers she has. A decision to order more numbers will be made at the February meeting.

**ZONE 7 SHOW DELEGATE:** Marjorie appointed Barbara Mantini as one of the GSPHC Zone 7 Show delegates since Marjorie is now Chairperson of the Zone 7 Committee.

**VERSATILITY CLASS:** This class will be held at the September show. It will consist of the following four individual classes: Hunter Under Saddle, Western Pleasure, Barrels, Equitation/Horsemanship. It will be held following the Saturday classes. One judge will be pulled to judge each individual class, plus a tie breaker judge. These judges will be announced just prior to the start of the Versatility class. There will be \$1,000.00 added. The payouts will be based on the number of entries in the class, following the APHA point schedule. Motion was made (Ware/Cerio) and passed that the entry fee for the Versatility class be \$100.00. Motion was made (Ware/Munn) and passed that all entries for the Versatility Class must be made at the office prior to the class entering the ring.

**NSBA:** Patti Cerio reported that she has not been able to reach anyone at the NSBA office. However, it is her understanding that applications to hold NSBA Stallion Incentive classes must be made in March and the NSBA office will notify the Show Committees in June if their show is accepted to hold NSBA classes. Further discussion on NSBA classes will be held at the February GSPHC meeting.

- 50/50 Raffles - the Youth Club will be holding a 50/50 at each of the GSPHC Paint Shows this year.

**GOLD STAR/CLUB OF DISTINCTION:** It was suggested that we could hold a Club Trail Ride at the Dream Park. This would be a worthwhile addition to our Club of Distinction report.

**CAKE SALE:** Debbie Kinney is Chairperson of a cake sale to be held in January to raise money toward the \$1,000.00 added to the September Versatility Class.

**APHA ARTICLE:** APHA has offered GSPHC a feature article in the APHA Journal. Jane Munn has developed and submitted the article.
