

GARDEN STATE PAINT HORSE CLUB
October 3, 2011

The meeting was called to order at 7:50 P<M by the President, Marjorie Moser, at the home of Dorothy and Milton Quirk. In attendance were: Cyndy Hetzel, Debbie Kinney, Barb Mantini, Jane Munn, Judy Moyer, Ken Ware, Sigrid Ware, Marjorie Moser, Mary Kensler, Ashley Nolasco, Dorothy Quirk.

MINUTES: The Secretary read a synopsis of the September minutes. A clarification to the minutes in reference to the Futurities is as follows. Jane Munn stated that, at the September meeting, she made a motion for the Club to add \$2,500 to the futurities, paying a maximum of 10 classes. Her motion was not passed. Patti Cerio then recommended that the Club add \$250 to each Futurity class. A motion was then made by Jane Munn, seconded by Ken Ware, and passed that "GSPHC add any monies needed to pay a maximum of \$250/class. Sponsorship monies will be included in that amount." Both Jane and Ken agreed that the motion should not have stated that the sponsorship monies would be included in the \$250/class amount but that those monies would be divided among the Futurity classes also. Motion was then made (Munn/K, Ware) and passed that the Futurity payouts should have read that GSPHC add \$250 for each Futurity class and any additional sponsorship monies also be added to the Futurity classes. As stated in the rules, 10% of the entry fees were kept by GSPHC to cover the Club's administration expenses. There were two classes individually sponsored for \$250: In Hand Trail and Western Pleasure. There were two additional \$250 sponsorships that were not designated for any class so those monies were added to the other two Futurity classes. An additional two \$50 sponsorships are being held over as start-up monies for the 2012 futurities. There was a total of 16 entries in the Futurity classes. GSPHC added \$1,000 to the Futurities and \$1,000 of sponsorships was added. In addition, there is \$100 in sponsorships to be held over for the 2012 futurities.

TREASURER'S REPORT: Mary Kensler reported that she has received one returned check. The income from the September Show was \$31,175. Show expenses were \$25,438. The balance on hand in the treasury when the Futurity checks have been mailed will be \$35,762.

The following APHA Convention bills were presented for payment:

Motion was made (Munn/Moyer) and passed to pay these Convention bills.

GLADING PLUS MONIES: Marjorie reported that the Gelding Plus monies given by APHA to the Zone Shows has now been reassigned to the Regional Clubs. At this time it is tentatively planned that 30 Regional Clubs will receive APHA monies. This is being done so that the APHA funding will be directly impacting Regional Clubs and not individuals.

STATE 4-H HORSE SHOW DONATION: Barbara Mantini asked Cyndy if she could get the Club a copy of the State 4-H Horse Show program showing that we donated to the show. This information is needed for our Gold Star and Club of Distinction paperwork.

APHA AD DONATED TO GSPHC: The Ad which APHA donated to GSPHC, won by Deb Wessner, was published in the last Journal.

SEPTEMBER SHOW: Jane Munn remarked that she has seen many favorable comments about the show posted on Facebook. Barbara Mantini will send the judges' cards from the Jersey Bred classes to Julie Bishop. Barbara reported that in 2012 Jersey Bred classes, for all breeds, will be held at individual breed shows, not at a Jersey Bred Show at the Horse Park.

NJ SUPERIOR ACHIEVEMENT AWARDS: Anyone having an eligible Jersey Bred horse is requested to send their nomination forms to Julie Bishop.

GSPHC QUEEN: Nominations for this are to be sent to Barbara Mantini.

GSPHC YOUTH CLUB REPORT: Cyndy Hetzell

- The Club will be attending the Equine Affaire in Massachusetts which is held in November.
- Youth Club sweatshirts and sweatpants are available for sale.
- Their Holiday Party will be held on the second Friday of December.
- A candle sale is in progress.
- Motion was made (Kensler/Nolasco) and passed that the Youth Club be permitted to use the GSPHC logo on decals and magnets which will be sold as

- a fundraiser. Anna Meade, who designed the logo, has given her permission to reproduce it provided there are no design changes made.
- A benefit fundraising Pancake Breakfast is being planned for Applebees. No date or location is set at this time.
- The Youth Club is planning on holding their July show again in 2012. The membership present recommended that the show be held again at the Gloucester County Fairgrounds. Motion was made (Munn/K. Ware) and passed that this show count in the future for GSPHC Club year end points.

DREAM PARK CONTRACT MEETING: Jane Munn reported that GSPHC representatives met with the Dream Park personnel to discuss the 2012 rental contract. They will meet again in October to finalize any agreement. Marjorie noted that exhibitors have complained about the wash racks being dirty. She explained that the wash racks are already in use when the Park employees report for work in the morning and are still being used when they are on duty during the day. They had been leaving wheelbarrows and pitchforks for exhibitors' use at all of the Park shows but many were stolen. Country Bistro has put in a bid to be the food service supplier for 2012.

APHA CONVENTION REPORT: Ken Ware reported that following items that passed:

- APHA Executive Committee members now have to live in the State they represent.
- When complaints are filed with APHA, witnesses may also testify on the problem reported.
- Paint horses that show Appaloosa characteristics can have their papers pulled.
- The Executive Committee can take action if shows advertise money payouts that aren't paid.
- The color classes can now receive Honor Rolls.
- Breaking of ties is now being put in writing.
- You will now be allowed to show 5 horses, not 4, in individual classes.
- Holding on to the saddle will now be, at the judge's discretion, either a penalty or disqualification
- The longe line classes will use the NSBA rules.
- The start and finish lines for the Stake Race will be explicitly delineated.

- Cowboy Shooting will not be an APHA class.
- Dressage will now be an APHA class.
- APHA judges will now only have to judge one show a year in order to keep their judge's card.
- An exhibitor cannot be a Novice Amateur once they have won \$2,500 in NSBA, etc. classes.
- Once an exhibitor holds a "Rodeo Card", they can no longer show as an Amateur in that class.
- Show Committees can combine classes that are not two point classes, without asking the exhibitors' permission.
- Walk Trot has been raised to 10 years of age. This does not affect GSPHC shows since that is not an APHA class at our shows.
- If a SPB horse goes into the Regular Registry, their show points go with them.

FUTURITIES: Motion was made (K. Ware/Nolasco) and passed that we have Futurities at our 2012 September show. Co-chairpersons: Jane Munn and Debbie Kinney.

SEPTEMBER SHOW - 2012: Jane suggested that we possibly distribute some type of show "Coupons" which can only be redeemed at the September show. This may encourage more exhibitors to show in September.

CASINO NIGHT: Debbie Kinney reported that everything is ready to go. She will be advertising in the local papers within the next two weeks.

SPB CLASSES: An inquiry was made about filling the SPB classes for GSPHC End of Year points. It was noted that End of Year points can only be awarded if the classes fill. Classes need three entries for GSPHC points. SPB exhibitors will have to "network" to fill these classes at the shows.

AWARDS BANQUET: Motion was made (K. Ware/S. Ware) and passed that the Club set a budget of \$5,000 for End of Year awards.

SUNSHINE CLUB 50/50: Was won tonight by Jane Munn.

The meeting was adjourned at 10:30 with the next regular meeting date set for Monday, November 7, at 7:30, at Dorothy Quirk's home. Members wishing to come and eat may do so at 7:00. Debbie Kinney will be providing the meal.
