TREASURER'S REPORT: Mary Kensler gave the following report:

- The cookie auction at the banquet realized a profit of \$261.00.
- The auction at the banquet realized a profit of \$436.00.
However, the banquet is not complete due to some outstanding bills.
- The Jersey Bred checks have been written. However, those are "money in - money out" from the Equine Advisory Board.
- Balance on hand to date: \$29,330.00

- Motion was made (Munn/K. Ware) and passed that the above bills be paid.

YOUTH CLUB REPORT: Ken Ware reported the following:

- The Club held an ice skating party.
- They participated in the Christmas Parade.
- The members have discussed asking for Youth Goat Tying to be included in the 2011 shows.
- The Youth Club collected 75 pillows to be donated to the women's shelter.

BENEFIT HORSE - BENEFIT RIDER CLASSES: Wendy Nichols was the Year End winner of these classes. She chose to have the \$800 collected donated to the Cumberland County SPCA.

TRAIL CLASSES: It was noted that the reason trail classes have not been considered to be held on Friday night prior to the Saturday-Sunday GSPHC shows is because GSPHC would have to pay the Dream Park an extra day's rental.

APHA RULE CHANGE: Judy Moyer reported that she will be re-submitting our rule change request that private APHA show sponsors not be permitted to sponsor

FUNDRAISING: Debbie Kinney suggested GSPHC sponsor a Beef and Beverage Poker Event. She has contacted the Salem County Sportsman Club and their rental fee is \$300 for a 5 hour rental. Tickets purchased would include a catered dinner and the Sportsman Club would be open to sell beverages. Following dinner, a poker tournament would be held. The winners of the tournament would receive prizes such as Visa cards, etc. She recommended holding this on a Saturday in March. Motion was made (Mantini/Munn) and passed for Debbie to have the Club put down a refundable \$100 deposit for the date of March 19, 2011.
