MINUTES: The Secretary gave a synopsis of the January minutes. The minutes were approved (Moyer/K. Ware) as read.

TREASURER'S REPORT: Mary Kensler reported:

- Scholarship Fund: \$1,395
- GSPHC Club Account: \$22,813
- A \$500 sponsorship was received from Dina Hurley / Crossroads Trailers.
- Callie Jo Ware's dinner cost of \$35 was paid for her participation at the EAB Equestrian event.

CORRESPONDENCE: Marjorie Moser reported that she had received a request from GSPHC members Jeannie Leppard and Betsy Leager that, at the upcoming APHA Convention, our APHA Director vote in favor of a Platinum category being added.

GSPHC YOUTH CLUB REPORT: Cyndy Hetzell reported:

- There are 6 GSPHC Youth members attending the Youth Conference in Fort Worth.
- Youth members are again going to be volunteering with the Handicapped Riding program at the Dream Park.
- The Youth Clinic is scheduled for March 15 at the Dream Park and will be held in the indoor coliseum.
- Ann and Mitch Leonarski will be presenters at the next Youth meeting.

SHOW SCHEDULES:

- Novice Amateur and Amateur classes will not be back/back on the show schedule.
- GSPHC will apply to APHA to add Challenged Horsemen's (CHAMPS) class/classes to the 2015 show schedule. There will be no entry fee for these class/classes. Horses do not have to be APHA registered. However, the horse's owner is required to be an APHA member.

GSPHC BY-LAWS: Judy Moyer reported that she has reviewed our By-laws and is recommending the following changes:

- Delete "Farm Memberships".
- Delete mention of the "Jersey Joggins" newsletter which is no longer in existence.
- Conduct a yearly audit.

- Clarify election procedures.

Judy's report will be considered the first reading of the By-laws changes.

CLUB SWEATSHIRTS/T-SHIRTS/ETC: Judy Moyer reported that she is checking into prices, etc. of both zippered and pull-over sweatshirts, etc. including nylon jackets as "Judges' gifts".

GSPHC SCHOLARSHIP: This application is now on the GSPHC website.

APHA CONVENTION: Judy Moyer is involved in conference calls with the Amateur Committee. Both Marjorie and Ken will be attending the Convention. One of the items to be discussed will be the transference of Virginia out of Zone 7. Items to be voted on at the Convention were discussed with the members present, including: APHA Directors being assigned 3 year terms, Directors who do not attend the APHA Convention will not be eligible to be a Director for 3 years, color requirements, meds, etc.
