GSPHC will be the first APHA Club to add a "Champs" class to their APHA show. There will be one class - a Trail (Obstacle) class. Marjorie will be sponsoring the awards. The horse being ridden does not have to be a Paint but the owner of the horse must be an APHA member.

FUTURITIES: Judy Moyer will contact our 2014 sponsors and see if they will support us again this year.

YOUTH CLUB REPORT: Cyndy Hetzell reported the following:

- They will soon be holding their annual flower sale.
- There will be a 50/50 at the April show.
- A basket auction will be held at the July show.

BASKET AUCTIONS: There will be both a "Doggie Basket" and a "Liquid Refreshment Basket" raffled off at the April show. GSPHC members are encouraged to bring items for both/either basket to the show.
