TREASURER'S REPORT: John Moser reported a balance on hand of \$14,379.00. The Club realized a profit of \$4,386.00 from the July show week-end. Motion was made (Kensler/K. Ware) and passed that the following bills be paid:

Lloyd Jerred: \$766.71 - airfare reimbursement for two judges

FUTURITIES: Patti Cerio reported that there will be 11 Futurity classes at the September show. Seven classes were cancelled due either to lack of entries or no entries. Motion was made (Moyer/B. Bleifuss) that the Club add \$2,000.00 to the Futurities this year. Motion was passed with one opposing vote cast by Kensler. It was noted that added Futurity monies must be advertised early in the year in order to promote entries. John Moser reported that there would be \$2,379.00 added to the Futurities with this motion and the raffle monies. Debbie Kinney volunteered to Chair the 2006 Futurity Fundraising Committee and also handle the 2006 Futurities. Patti noted that there were several Futurity rule clarifications that should be cleared up with individuals prior to the show. Margie will make these contacts. Patti will publish a Futurity audit after the September show.

BIF FUTURITIES: Judy Moyer reported that there were six stallions sold this year and that the BIF will have nine entries. The BIF Futurity will be discussed at the October Club meeting. Anyone with any ideas on changes, etc., please bring them to that meeting.

JERSEY BRED HORSE SHOW: Julie Bishop reported that the show had been held on Sunday, September 11. Discussion ensued.
