Every entry at a recognized show shall constitute an agreement and affirmation that the person making it, along with the owner, lessee, trainer, manager, agent, coach, driver, and the horse (1) shall be subject to the Constitution and rules of their Association and the local rules of the show; (2) that every horse, rider and/or driver is eligible as entered; (3) that the owner and any of his representatives are bound by the Constitution and Rules of the show and will accept as final the decision of the hearing committee on any question arising under said rules and agree to hold the show and their officials, directors and employees harmless for any action taken; (4) that the owner, rider/driver and any of their agents or representatives agree to hold the show and their officials, directors, employees and agents harmless for any injury or loss suffered during or in connection with the show, whether or not such injury or loss resulted directly or indirectly, from the negligent acts or omissions of said officials, directors, employees or agents of the show. Under New Jersey Law .an. area operator is not liable for an injury to or the death of a participant in Equine animal activities resulting from the inherent risk of equine animal activities, pursuant to PL1997,c287,c5:15-1 ET SEQ. A participant shall submit a written report to operator setting forth the details of any accident or incident as soon as possible, but no longer than 180 days from the time of the accident or incident.
